PondClear Directions For Use

HOW TO APPLY: **DO NOT OPEN PACKETS!**

Packets are to be applied directly to the water. Distribute packets from shore or boat. PondClear works best when evenly disbursed across the body of water.

WHEN TO APPLY: Apply every two weeks when water temperatures are above 50° F.

QUICK DOSE CHART

Pond Size (surface acres)	Dosage Rate (every two weeks*)	Months of Treatment
Up to 1/4 acre	2 packets	24
Up to 1/2 acre	4 packets	12
Up to 3/4 acre	6 packets	8
Up to 1 acre*	8 packets	6

*For ponds larger than one acre, use 8 packets per surface acre every 4 weeks.

WATER USE RESTRICTIONS:

PondClear may be applied to lakes and ponds used for irrigation and aquaculture. Water treated with PondClear may be used for recreation, fishing and other activities immediately after treatment.
